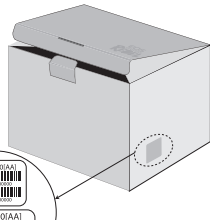
1. Check all applicable boxes on the front of this rebate claim form.

3. Attach the following:

- A. **Copy** of dated sales receipt showing purchase of qualifying Canon product(s).
- B. **Copy** of Customer Portion of the Canon USA warranty card with imprinted model and body or lens number. (See picture below for example)
- C. **Original** cutout of UPC code(s) and body or lens number(s) from product(s). (See picture below for example)
