

# Amazon.com Mail-In Rebate for Qualifying Brother Products

## OFFICIAL RULES & REGULATIONS

1. Complete this Rebate Claim Form. Please note that rebate claims must be received by mail at the address shown on this form and cannot be received by e-mail.
2. Submit a copy of the sales receipt showing the product purchased and purchase date (dated between 01/20/06 and 01/26/06).
3. Submit the proof-of-purchase by cutting out the original UPC "For Customer Use" bar code from the side of the carton.
4. Rebate form and supporting documents (collectively "Claim") must be postmarked no later than February 25, 2006 and be received by March 27, 2006. Please allow six to eight weeks to process.
5. This form must be signed in order to be valid.

9. Any misrepresentations or fraudulent information disqualifies the claim.
